LETTER OF NOMINATION

You are required to obtain one letter of nomination from a representative of your school. A school representative would be any school employee that is not a relative of the student applying. This letter must be on school letterhead and signed. The letter should speak to your character and recommend you for participation on the Junior Board of Directors.

SELECTION CRITERIA

Up to 10 students will be accepted into the Junior Board of Directors program for the 2022-2023 school year. All students are eligible to apply regardless of whether their parents/guardians are members of Kankakee Valley REMC. Individuals will be selected based on their application.

PROGRAM COMMITMENT

The Junior Board of Director meetings will take place during the school day. Students selected for the program must provide their own transportation to and from Kankakee Valley REMC (8642 W. US Hwy 30; Wanatah). A commitment to fully participate and attend all monthly sessions is expected.

A \$1,000 scholarship will be awarded to each student who completes the nine-month program. Students are allowed to miss two (2) Junior Board of Directors sessions. If a student should miss more than two (2) sessions, they will be excused and no longer eligible for the scholarship. Exceptions are at the discretion of the KV REMC employees serving as advisors to the board.

Students should seek approval from school administrators to be excused from school to attend the scheduled monthly sessions.

STATEMENT OF AGREEMENT

If selected to serve on the Junior Board of Directors, I will:

- Represent Kankakee Valley REMC, all youth and the Junior Board of Directors program honorably.
- Authorize the Kankakee Valley REMC advisors for the Junior Board of Directors program to take appropriate measures should I not be able to fulfill the duties and requirements listed on this application.
- Hold harmless Kankakee Valley REMC, its employees and board members for any injuries or illness received during my participation.
- Give permission for photographs and video to be taken of me while participating in a Junior Board of Directors activity or meeting.
- Provide my own transportation to and from Kankakee Valley REMC where all events will take place.
